

# LIVINGSTON BOARD OF EDUCATION WORKSHOP/VOTING MEETING MINUTES

October 8, 2024

## **Superintendent's Report**

# Public Hearing for District and School HIB Self-Assessment Report

Mrs. Steiger explained that annually the district is required to complete a HIB self-assessment for the prior school year, present it to the Board of Education and share it with the Department of Education. The nine anti-bullying specialists in the district spend the year gathering information to complete the self-assessment. The self-assessment is made up of a variety of components through eight core elements that include HIB programs, approaches and other initiatives, training, curriculum and instruction, programming and reporting procedures. The data is used to address district challenges and provide professional development in areas needed. This year our composite score was 77.44 out of a possible 78 points.

# NJSLA Scores

Mrs. Natalie Topylko, Director of Curriculum and Instruction, presented the NJSLA Spring 2024 results from the assessments for English Language Arts and Mathematics in grades 3-9 and for Science in grades 5, 8 and 11. Mrs. Topylko reviewed the participation levels and went through the data showing students' performance levels in all of the assessments. The cohort chart shows how students progress each year from grade through 9.

Mrs. Topylko explained we use a collaborative process to analyze the data and to develop action plans that impact professional development, classroom instruction and curriculum development/materials selection.

Moving forward, we will continue with the implementation of the universal screening tool for grades 2-5 as a means of analyzing student needs for differentiated and small group instruction and skills tracing and continue to examine beginning of the year assessments to analyze and triangulate these with the NJSLA scores and classroom observations and assessment. In Science, we are continuing to collaborate with the NJDOE to pilot a new Open Sci Ed curriculum in the elementary grades. In ELA, we will perform Word Study Work in grades K-1 for both decoding and comprehension. In Math, we are continuing the implementation of Math in Focus in grade 6, emphasizing small group instruction and the implementation of the Tier 1 toolkit, and for grade 8, examining instructional materials, program and professional development for staff.

Mrs. Khemka said that universal screener will be able to identify more children with gaps at an earlier age hence needing differentiated learning. She requested we keep an eye on it from the perspective of budget and what extra support teachers in elementary schools may need.

Our student government formed a relationship with the Millburn student government and discussed playing into their school rivalries to promote school spirit at both schools. Millburn may also plan their own Lip Dub and the two groups discussed competing for the winning Lip Dub using the most likes and views on social media platforms. Miss Bialick continued that the

first TikTok was posted on the new SGA account to promote spirit week, which is being held from October 7 to 11 and garnered over 2,400 views.
